My family and I want to send a very special thank you to all who sent emails, prayers, condolence cards, phone calls, attended the viewing or the funeral of my son-in-law Tyler Gullette.

The members of VVA Chapter 920 both Brothers, Sisters, their wives or husbands are very special to me.

Tyler held a special place in my heart he was a real good son-in-law, I could always depend on him if I needed help with something. Tyler had a way about him that attracted people to him one thing he did have was the voice of a Angel and the knowledge of the Bible that he love to share. Tyler's way of performing a church service was a real unique system he would cover many verses from different chapters in the bible and quite frequently add in a song many times that he had wrote.

He spent time praying with prisoners, he worked for hospice and he would sit and sing and pray with someone that hospice was called in for. He told me that he had quite a few people in hospice that died in his arms as he sang to them.

At one time Tyler was a member of the Honor Guard and would often sing the National Anthem at special occasions.

So, you see what kind of a man he was - real special.
